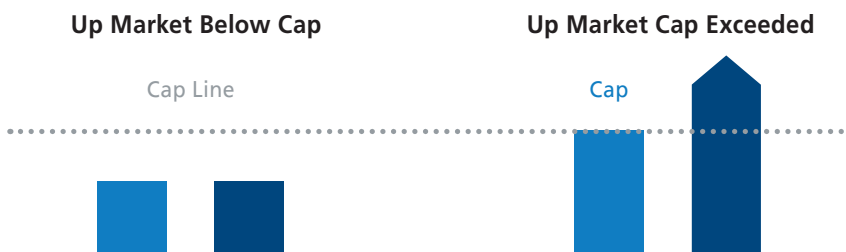

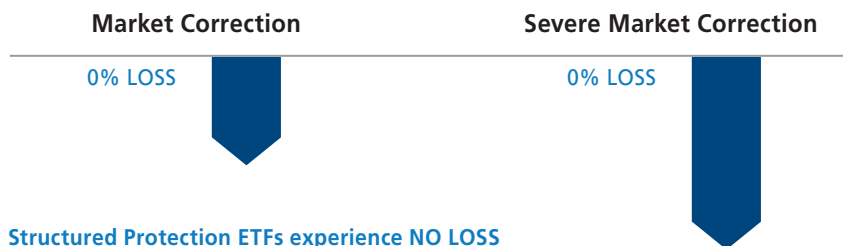

## OVERVIEW

Calamos Structured Protection ETFs are designed to match the positive price return of the Nasdaq-100<sup>®</sup> up to a defined cap while protecting against 100% of losses over a one-year period (before fees and expenses).

## OUTCOME PERIOD CAP RATE

The starting cap rate for CPNS as of September 2, 2025, is 7.01% gross of the annual expense ratio.
