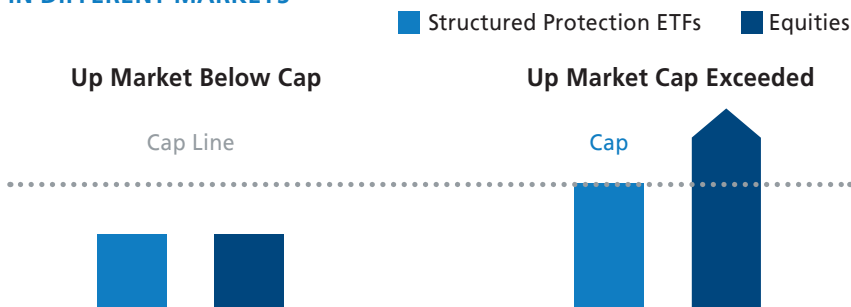

The starting cap rate for CPSM as of May 1, 2026, is 6.74% gross of the annual expense ratio.

In some cases, the protection is lowered from the maximum of 100% to provide a minimum "cap" of 1%.
