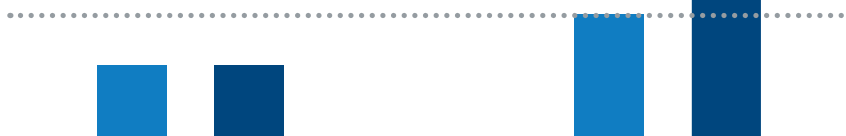

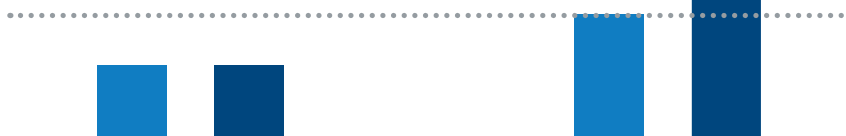

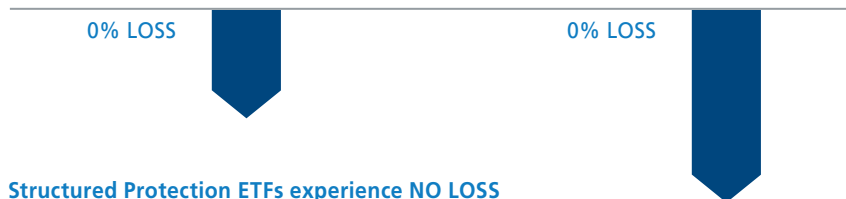
Market Correction

OVERVIEW

Calamos Structured Protected ETFs are designed to match the positive price return of the S&P 500[®] up to a defined cap while protecting against 100% of losses over a one-year period (before fees and expenses).

OUTCOME PERIOD CAP RATE

The starting cap rate for CPSO as of October 1, 2025, is 6.40% gross of the annual expense ratio.

In some cases, the protection is lowered from the maximum of 100% to provide a minimum "cap" of 1%.
