Debt/capital ratio is a measure of a company's financial leverage, calculated as the company's debt divided by its total capital.

Est 1-year EPS growth is an average of the estimated short-term earnings growth for the companies in a portfolio and gauges the growth potential of a portfolio's underlying companies.

Est 1-year sales growth is an average of the estimated sales growth for companies in a portfolio, thereby projecting their ability to increase revenue.

PEG ratio is a stock's price/earnings ratio divided by the estimated earnings growth rate in the next year; a lower PEG indicates that less is being paid for each unit of earnings growth.

Portfolio turnover is the percentage of assets in a portfolio that changed over a certain period, often a year; higher turnover indicates greater buying and selling activity.

ROIC (return on invested capital) measures how effectively a company uses the money invested in its operations, calculated as a company's net income minus any dividends divided by the company's total capital.

The Russell 2000[®] Growth Index measures the performance of the small-cap growth segment of the US equity universe. It includes those Russell 2000[®] companies with higher price-to-value ratios and higher forecasted growth values. The Russell 2000[®] Growth Index is published and maintained by FTSE Russell.

Morningstar Small Growth Category funds focus on faster-growing companies whose shares are at the lower end of the market-capitalization range. Stocks in the bottom 10% of the capitalization of the US equity market are defined as small cap. Growth is defined based on fast growth (high growth rates for earnings, sales, book value, and cash flow) and high valuations (high price ratios and low dividend yields).
